



## Possible Outcomes on Recommendations for Applications of Teacher Registration/ Teacher Appointment Purpose (July 2016)

### 1. If you possess teacher training qualification(s), we will also consider if your qualification(s) meets the guidelines of the local teacher training qualifications below, as stipulated by Education Bureau:

Postgraduate Diploma in Education  
Postgraduate Diploma in Education in Early Childhood Education  
Bachelor of Education Degree  
Bachelor of Education in Early Childhood Education Degree  
Teacher's Certificate  
Certificate in Early Childhood Education  
Qualified Kindergarten Teacher qualification

### 2. If you do not possess teacher training qualification(s)/ your teacher training qualification(s) does not meet the guidelines of the aforementioned teacher training qualification(s), we will consider if your qualification(s) meet the minimum Academic Qualification Requirements of Permitted Teacher in Hong Kong listed below:

Remark	School Type	Minimum Academic Qualification Requirements
1	Primary / secondary or post-secondary education	The minimum academic requirement of a permitted teacher who teaches in a school providing primary/secondary or post-secondary education is an associate degree, a higher diploma or equivalent. In general, a teacher has to possess higher qualifications if he/she is required to teach at higher level.
2	Nursery and kindergarten education	The minimum academic requirement of a permitted teacher who teaches pupils undergoing nursery and kindergarten education is 5 separate subjects at acceptable level in the Hong Kong Diploma of Secondary Education Examination, including Level 2 in both English Language and Chinese Language and any combination of the following—(i) Level 2 in New Senior Secondary subjects; (ii) “Attained” in Applied Learning subjects (subject to a maximum of two Applied Learning subjects); and (iii) Grade E in Other Language subjects in not more than two sittings.
3	A school offering other educational courses, e.g. tutorial, commercial, language and computer courses	The minimum academic requirement of a permitted teacher who teaches in a school offering other educational courses, e.g. tutorial, commercial, language and computer courses is 5 separate subjects at acceptable level in the Hong Kong Diploma of Secondary Education Examination, including Level 2 in English Language or Chinese Language and any combination of the following—(i) Level 2 in New Senior Secondary subjects; (ii) “Attained” in Applied Learning subjects (subject to a maximum of two Applied Learning subjects); and (iii) Grade E in Other Language subjects in not more than two sittings.

### 3. Year of attainment of Bachelor degree status will be commented if applicable
