#### Guidance Notes 申請須知

Applicants should read the following notes carefully before submitting an application for review. 申請者在遞交覆檢申請表前,須詳閱以下注意事項。

- 1. This Application Form is for use by an individual who is aggrieved by the decision made by the Hong Kong Council for Accreditation of Academic and Vocational Qualifications (HKCAAVQ) on his/her qualifications assessment and wishes to seek a review in accordance with the provision in sections 17A to 17D under the HKCAAVQ Ordinance (Cap. 1150).
  - 根據香港學術及職業資歷評審局條例(第 1150 章)第 17A 至 17D 條 (簡稱條例),任何個人如因香港學術及職業資歷評審局(簡稱評審局)對其作出的學歷評估評定感到受屈,可向評審局申請覆檢。此申請表只適用於覆檢評審局的學歷評估評定。
- According to the HKCAAVQ Ordinance, the review will be dealt with by the Standing Review Committee for Qualifications Assessment (the Committee) established by the Council. The Committee then makes recommendations to the Council. The decision made by the Council based on the recommendations of the Committee is final.
  - 根據條例,覆檢將由評審局大會成立之學歷評估覆檢常務委員會(簡稱委員會)處理。評審局大會將基於委員會的建議,作出最終之決定。
- 3. Applicants should provide the grounds for applying for review. If applicants submit any new materials/information in support of their application, such new materials/information may be accepted only if they were in existence before HKCAAVQ made the decision on the assessment concerned. Applicants are required to provide reasons as to why such materials/information were not made available to HKCAAVQ during the assessment. It should be noted that a review is neither a new assessment nor an extension of the one under dispute.
  - 申請者須提供申請覆檢的理據。所有增補文件/資料如其發出日期為評審局作出評估評定前經已發出,委員會將考慮接納其作覆檢之用。如申請人欲提交符合上述情況的增補文件/資料,則必須清楚解釋其未能在評估過程時向評審局遞交此資料的因由。在任何情況下,本覆檢並非一次重新的評估或其延續服務。
- 4. According to the HKCAAVQ Ordinance, the completed Application Form must reach the Council (Address: 10 Siu Sai Wan Road, Chai Wan, Hong Kong) within 30 days of the receipt of HKCAAVQ's assessment decision by the applicants together with the original payment evidence of the review fee and new materials/information (if any). Otherwise the review mechanism will not be initiated.
  - 根據條例,申請者須於收到有關評估決定的通知日起計 <u>30 天內</u>提出覆檢申請。填妥的申請表格須連同增補文件/資料(如有)及繳付覆檢費用證明正本,於限期前一併遞交到香港柴灣小西灣道 10 號。如未能符合上述條件,覆檢程序將不能啟動。

- 5. The review fee is one-third of the original assessment fee. The review fee can be settled by one of the following means:
  - (i) Cash deposit in Hong Kong currency into one of the following bank accounts:
    - (a) Name of the Bank: Industrial and Commercial Bank of China (Asia) Limited; Name of Account: Hong Kong Council for Accreditation of Academic and Vocational Qualifications; Account Number: 861-502-02007-3; or
    - (b) Name of the Bank: The Bank of East Asia, Limited; Name of Account: Hong Kong Council for Accreditation of Academic and Vocational Qualifications; Account Number: 514-40-58393-6; or
  - (ii) **Crossed cheque** from a bank account in the HKSAR in Hong Kong currency to "Hong Kong Council for Accreditation of Academic and Vocational Qualifications".

For applicants outside Hong Kong, the review fee can also be settled by telegraphic transfer in the following designated format:

(iii) **Telegraphic transfer** (*Name of the Bank*: Industrial and Commercial Bank of China (Asia) Limited; *Address*: 33/F, ICBC Tower, 3 Garden Road, Central, Hong Kong; *Swift Code*: UBHKHKHH; *Name of Account*: Hong Kong Council for Accreditation of Academic and Vocational Qualifications; *Account Number*: 861-502-02007-3). The original payment evidence by telegraphic transfer or any other relevant evidence clearly showing the Applicant's identity should be attached to the Application Form.

- 6. The review fee is not refundable, except when the review outcome is a variation of the original determination and/or decision of the Council.

- 7. The personal data provided in this Form will be used by the Committee and the Council for review purposes and any other legitimate purposes as may be required, authorised or permitted by law. In general, all submitted documents will be retained for a period of ten years.
