# Subsidy for Persons Holding Non-local Qualifications to Conduct Qualifications Assessment (SNQQA) Guidance Notes

## 持有非本地學歷人士進行學歷評估資助(非本地學歷評估資助) 申請須知

#### I. Programme Information

#### 計劃資料

- 1. SNQQA is one of the regular assistance programmes subsidised by the Education Bureau (EDB). 非本地學歷評估資助是教育局的其中一項恆常資助計劃。
- 2. SNQQA provides subsidy for needy persons to conduct qualifications assessment for general purpose. 非本地學歷評估資助是為資助有經濟需要的人士進行用作一般用途的學歷評估。
- 3. SNQQA is jointly implemented by the Hong Kong Council for Accreditation of Academic and Vocational Qualifications (HKCAAVQ) and EDB.

非本地學歷評估資助由香港學術及職業資歷評審局(評審局)及教育局合作推行。

## II. Eligibility Criteria

## 受惠資格

Target beneficiaries must fulfil all the following 3 criteria:

受惠人士須符合以下三項條件:

- 1. holding non-local qualifications which have not yet been assessed by HKCAAVQ. 持有非本地學歷而有關學歷未經香港學術及職業資歷評審局進行學歷評估。
- 2. being one of the following categories of Hong Kong resident<sup>1</sup>:

- (1) holders of Hong Kong permanent identity cards; or 持香港永久性居民身份證的人士;或
- (2) persons who have come from the Mainland to Hong Kong for settlement on "Permit for Proceeding to Hong Kong and Macao" (commonly known as One-way Permit) but not yet obtained Hong Kong permanent identity cards; or 持前往港澳通行證(慣稱「單程證」)從內地來港定居,但尚未取得香港永久性居民身份證的人士;或
- (3) ethnic minorities who are holders of Hong Kong identity cards and (i) have the right to land; or (ii) on unconditional stay in Hong Kong; or (iii) permitted to stay in Hong Kong as dependants (and their sponsors are Hong Kong permanent residents, or non-permanent residents with the right to land or on unconditional stay in Hong Kong), but have not yet obtained Hong Kong permanent identity cards.

## **III. Application Procedures**

## 申請程序

1. Applicants are required to submit **BOTH** the SNQQA Application Form and the Application Form for Qualifications Assessment.

申請人需同時提交非本地學歷評估資助申請表格及學歷評估申請表格。

Note: The Application Form for Qualifications Assessment is to be filled in and submitted on the HKCAAVQ <u>OA i-Portal</u> direct. The SNQQA Application Form, available on the <u>QA i-Portal</u>, as well as the supporting documents, can be submitted to HKCAAVQ by uploading onto the <u>QA i-Portal</u>. SNQQA applicants are not required to pay any assessment fees at the time of application.

注意: 學歷評估申請表格需於<u>學歷評估服務平台</u>直接填寫及遞交。非本地學歷評估資助申請表格可在<u>學歷評估服務平台</u>下載,填妥的申請表格及證明文件,可以上載到<u>學歷評估服務平台</u>。申請人於遞交申請表格時不需支付評估費用。

2. On receipt of the application forms and supporting documents, HKCAAVQ will verify the eligibility of SNQQA applicants and then issue them an acknowledgement. The assessment will normally take 15 working days starting from the next working day of the acknowledgement.

評審局收到申請表格及證明文件後,會於初步審查後向合資格的非本地學歷評估資助申請人發出申請覆函。由發出 覆函的下一個工作天起計,評估工作一般需時十五個工作天。

- 3. Applicants not eligible for SNQQA, if they are willing to bear the assessment fees on their own as indicated in Section B.4 of SNQQA Application Form, can still proceed with qualifications assessment at their own expenses.
  - 未符合資格申請非本地學歷評估資助的人士,若已在非本地學歷評估資助申請表格乙部第 4 項表明同意支付全部評估費用,也可自行支付評估費用繼續進行學歷評估。
- 4. HKCAAVQ will, after completion of the qualifications assessment, issue a report for Qualifications Assessment (the Report) stating its professional opinion on whether the totality of the applicants' educational qualifications meets the standard of a particular level of qualification in Hong Kong.
  - 評審局完成評估工作後,會透過學歷評估報告,說明評審局對申請人總體學歷是否達到在香港取得的某特定資歷級 別的標準之專業意見。
- 5. Applicants who are aggrieved by HKCAAVQ's assessment determination may apply for review within 30 days of the receipt of the Report. Applicants are required to pay the review fee (the review fee is one-third of the original assessment fee) which will not be covered by SNQQA.

申請人如因評審局的評估評定感到受屈,可於收到評估報告日起計 30 天內向評審局申請覆檢。申請人需自行負責有關的覆檢費用(覆檢費用為學歷評估費用的三分之一),非本地學歷評估資助不會資助覆檢費用。

#### **IV. Preparing Supporting Documents**

## 準備證明文件

- Generally speaking, applicants are required to provide three types of supporting documents when applying for SNQQA, namely
  documentary evidence of non-local qualifications, personal identification documents and records of receipt of assistance under
  any of the specified assistance schemes. Documents written in languages other than Chinese and English must be accompanied
  by certified Chinese or English translations.
  - 一般來說,非本地學歷評估資助申請人需要提供三類文件,分別為非本地學歷證明文件、身份證明文件及受惠於特定資助計劃的證明文件。如文件並非以中文或英文寫成,申請人必須提供中文或英文核證翻譯本。
- 2. For documentary evidence of non-local qualifications, please refer to <u>Qualifications Assessment Guidance Notes for Application</u> available on HKCAAVQ website.

有關非本地學歷證明文件,詳情可參閱評審局網站的學歷評估—申請指引。

- 3. As for personal identification documents and records of receipt of assistance under any of the specified assistance schemes, applicants should provide copies of the supporting documents. 至於身份證明文件及受惠於特定資助計劃的證明文件,申請人須遞交證明文件的副本。
- 4. Regarding personal identification documents, applicants with Hong Kong permanent identity cards are required to submit a copy of their permanent identity card only. Non-permanent resident applicants are required to provide a copy of their Hong Kong identity card, and a copy of their valid travel documents (including travel document pages showing personal particulars, and landing endorsements/landing slips with unexpired limit of stay issued by the Hong Kong Immigration Department) or the "Permit for Proceeding to Hong Kong and Macao" (commonly known as One-way Permit). Copy of "Certificate of Registered Particulars" issued by the Hong Kong Immigration Department should also be submitted if the English name appears on the "Permit for Proceeding to Hong Kong and Macao" is different from the English name appears on the Hong

Kong identity card.

在提交身份證明文件時,香港永久性居民於申請時只需提交香港永久性居民身份證副本。如非香港永久性居民,則須於申請時遞交香港居民身份證副本,以及有效旅行證件(包括個人資料頁、附有香港入境事務處發出逗留期限尚未屆滿的簽注/入境標籤的證件內頁)或前往港澳通行證(慣稱「單程證」)的副本。如前往港澳通行證上的英文姓名與香港居民身份證上的英文姓名不同,需提供由香港入境事務處發出的登記事項證明書的副本。

- 5. Regarding records of receipt of assistance under any of the specified assistance schemes, applicants should submit the notification letter of any of the specified assistance schemes. The notification letter should fulfil the assistance level and claim period requirements. If SNQQA applicants are spouses of the Major Recipients of the specified assistance schemes, a copy of the marriage certificate and a copy of the Major Recipient's Hong Kong identity card should also be submitted. 有關受惠於特定資助計劃的證明文件,申請人須提交特定資助計劃的通知書副本,而該通知書須符合有關資助水平及資助期的要求。如非本地學歷評估資助申請人為資助計劃主要受惠人的配偶,則須另外遞交結婚證明書副本及主要受惠人的香港居民身份證副本。
- 6. The notification letter of the specified assistance schemes, submitted by SNQQA applicants, should meet the following assistance level requirement:

- (3) School Textbook Assistance Scheme (for full grant only) 學校書簿津貼計劃(只包括全額書簿津貼)
- (4) Kindergarten and Child Care Centre Fee Remission Scheme (for full or 3/4 remission) 幼稚園及幼兒中心學費減免計劃 (包括全額、3/4 額學費減免)
- 7. The notification letter submitted should also meet the claim period requirement, i.e. the period for the receipt of assistance stated in the notification letter should be not more than 12 months from the date of application for SNQQA. 有關通知書亦須符合資助期的要求,即通知書中所載的資助期須相距非本地學歷評估資助申請不多於 12 個月。

## V. Subsidy Coverage

## 資助範圍

- 1. All eligible applicants are entitled SNQQA once. In addition, the applicants are not eligible for SNQQA if the applicants have received subsidy from the Community Care Fund Assistance Programme Subsidy for Persons Holding Non-local Qualifications to Conduct Qualifications Assessment for the period from September 2017 to August 2020.
  - 所有合資格申請人在非本地學歷評估資助下,只可以<u>受惠一次</u>。如申請人曾於 2017 年 9 月至 2020 年 8 月期間獲得關愛基金資助進行學歷評估,將不可再度申請非本地學歷評估資助。
- 2. SNQQA covers the assessment fee for conducting qualifications assessment for general purpose. Please refer to the HKCAAVQ website for details regarding the assessment fee.

SNQQA does not cover postage, translation or review fee.

## VI. About Personal Information

#### 有關個人資料

- 1. It is the responsibility of the applicants to complete the application form fully and truthfully and to provide all supporting documents. Providing partial, false and misleading information will render the application for SNQQA deferred or disqualified.
  - 申請人有責任詳實及真確地填妥申請表格及提供所有證明文件。如只提交部分、錯誤或誤導資料,非本地學歷評估資助申請將被延誤或遭取消。
- 2. The personal data provided in the application for SNQQA, including those in the supporting documents, will be used by HKCAAVQ and EDB and relevant government bureaux/departments for the following purposes:
  - 申請人在申請非本地學歷評估資助及有關證明文件所提供的個人資料,將會被評審局和教育局及有關政府政策局/部門作下列用途:
  - (1) processing the application for SNQQA; 處理非本地學歷評估資助申請;
  - (2) verifying with records held by relevant government bureaux/departments for validating the eligibility of the applicants for SNQQA, either in the process of application or after the release of assessment results;
    - 與有關政府政策局/部門所持有的資料作對比,以確認申請人符合非本地學歷評估資助的受惠資格,而有關對比工作可能在申請過程中或學歷評估報告發出後進行;及
  - (3) compiling statistics and producing progress/evaluation reports.

## 主要詞彙表

## **SNQQA**

It refers to the "Subsidy for persons holding non-local qualifications to conduct qualifications assessment" subsidised by EDB.

## specified assistance schemes

4 assistance schemes are selected for determining the applicants' financial status as an eligibility criteria for SNQQA. For details, please refer to the entry on **assistance level requirement** in this Glossary.

## Major Recipient

The Major Recipient refers to the applicant who has passed the means-test establishing eligibility for assistance under any of the specified assistance schemes and receiving assistance. The Major Recipient is also the addressee of the notification letter of any of the specified assistance schemes.

#### notification letter

The letter issued to the Major Recipients of the specified assistance schemes notifying them the results of their applications. It normally includes the assistance level within a specific claim period.

## assistance level requirement

Applicants are required to submit the notification letter of the specified assistance schemes. The notification letter should fulfil two requirements and one of them is the assistance level requirement. The level of assistance for different specified assistance schemes are provided as follows:

- 1. Comprehensive Social Security Assistance Scheme (any level of assistance)
- 2. Working Family Allowance Scheme (any level of assistance)
- 3. School Textbook Assistance Scheme (for full grant only)
- 4. Kindergarten and Child Care Centre Fee Remission Scheme (for full or 3/4 remission)

### claim period requirement

Applicants are required to submit the notification letter of the specified assistance schemes. The notification letter should fulfil two requirements and one of them is the claim period requirement, i.e. the period of receipt of assistance stated in the notification letter should be no more than 12 months from the date of application for SNQQA.

主要受惠人即通過任何一項特定資助計劃的住戶經濟審查並領取資助的申請人。主要受惠人亦同時為特定資助計劃通知書的抬頭人。

#### 通知書

通知主要受惠人有關特定資助計劃申請結果的文件。通知書一般列出資助期及資助水平資料。

## 資助水平要求

申請人須提交特定資助計劃的通知書。有關通知書須符合兩項要求,其中一項為資助水平要求。各項特定資助計劃的資助水平要求詳列如下:

- 1. 綜合社會保障援助計劃(任何程度的資助)
- 2. 在職家庭津貼計劃(任何程度的資助)
- 3. 學校書簿津貼計劃 (只包括全額書簿津貼)
- 4. 幼稚園及幼兒中心學費減免計劃(包括全額、3/4額學費減免)

## 資助期要求

申請人須提交特定資助計劃的通知書。有關通知書須符合兩項要求,其中一項為資助期要求,即通知書中所載的資助期須相距非本地學歷評估資助申請不多於12個月。
